1 | Introduction

Rödl & Partner USA is committed to protecting your privacy. This privacy statement describes why and how we collect, use, and share personal information collected from individuals themselves or from other third parties, and provides information about individuals' rights with respect to their personal information. We may use personal information provided to us for any of the purposes described in the relevant section of this privacy statement or as otherwise stated at the point of collection.

At Rödl & Partner USA we have focused on implementing practices that are designed to protect your privacy. We believe it benefits all parties if information is gathered, used and shared responsibly and in a transparent manner.

2 | Scope

This statement applies to Rödl Management, Inc. (dba Rödl & Partner USA) and the following associated entities (Rödl Langford de Kock LLP, Rödl Langford de Kock LLP).

3 | Corporate Accounting Services

Our Policy is to collect only the necessary personal information for the agreed purposes, and we ask our clients to share personal information only when it is needed for those purposes. When we need to process personal information to provide our services, we ask our clients to provide the necessary information to the data subjects concerned regarding how Rödl & Partner USA will process that personal information, as our clients are typically in the appropriate position to communicate this information to the data subjects.

3.2 INFORMATION USE

We use the provided personal information for the following business purposes:

 - Personal information may be processed as part of security monitoring that we undertake to detect, investigate and resolved security threats
 - We monitor the services provided to clients for quality and risk purposes, which may involve processing personal information stored within Rödl & Partner USA's data environment.
 - We collect and hold personal information as part of our client engagement and acceptance procedures, including carrying out search using publicly available sources.
- Complying with any requirement of law, regulation or professional body of which we are a member
 - Rödl & Partner USA is subject to legal, regulatory and professional obligations. We retain certain records to demonstrate our compliance with those obligations and those records may contain personal information.

3.3 <u>INFORMATION RETENTION</u>

Rödl & Partner USA retains the personal records processed by us for as long as is considered necessary for the purpose for which it was collected. Certain information may be held for longer periods where extended retention periods are required by law, regulation, or professional standards and to establish, exercise or defend our legal rights.

3.4 <u>INFORMATION SHARING</u>

Our work may require at times for us to pass information to third-party service providers, agents, subcontractors and other associated organizations for the purposes of completing tasks.

Rödl & Partner USA takes privacy seriously and will only use personal information to provide the services requested from us, detailed in the *Letter of Engagement*.

3.4.1 THIRD PARTY ORGANIZATIONS

On certain client engagements, we may engage or otherwise work with other providers to help provide professional services to our clients. When a third-party provider is engaged, we disclose only the personal information necessary to deliver the services. Assurances are required of third-party providers that will safeguard information passed to and from them in compliance with appropriate laws and regulations.

3.4.2 DATA RESIDENCY

In order to render certain services, we may be required to transfer, store, and process personal information in jurisdictions other than where the corporation may reside. All data will be stored within Rödl & Partner USA data environment within the United States and therefore will be administered in accordance with US data protection laws.

4 | Personal Accounting Services

Our policy is to collect only the personal information necessary for agreed purposes, and we ask our clients only to share personal information when it is needed for those purposes. When we need to process personal information relating to individuals other than our clients to provide our services, we ask our clients to provide the necessary information to other data subjects concerned, such as family members, regarding its use.

4.1 <u>INFORMATION COLLECTION</u>

Given the diversity of services we provide to clients, we store and process many categories of personal information:

- Personal Details (e.g., name, age/date of birth, gender, marital status, country of resident, SSN, ITIN)
- Family Details (e.g., dependents and other household information)
- Contact Details (e.g., email address, phone number, postal address)
- Financial details (e.g., salary, payroll details and other financial-related details such as income, investments and other financial interests)

For certain services, and when permitted by law, we may also collect sensitive or special categories of personal information.

Generally, we collect personal information directly from our clients or from a third party acting on the instructions of the client.

4.2 <u>INFORMATION USE</u>

We use the provided personal information for the following business purposes:

- Providing professional services and products
- Security, quality and risk management activities
 - Personal information may be processed as part of security monitoring that we undertake to detect, investigate and resolve security threats
 - We monitor the services provided to clients for quality and risk purposes, which may involve processing personal information stored within Rödl & Partner USA's data environment.
