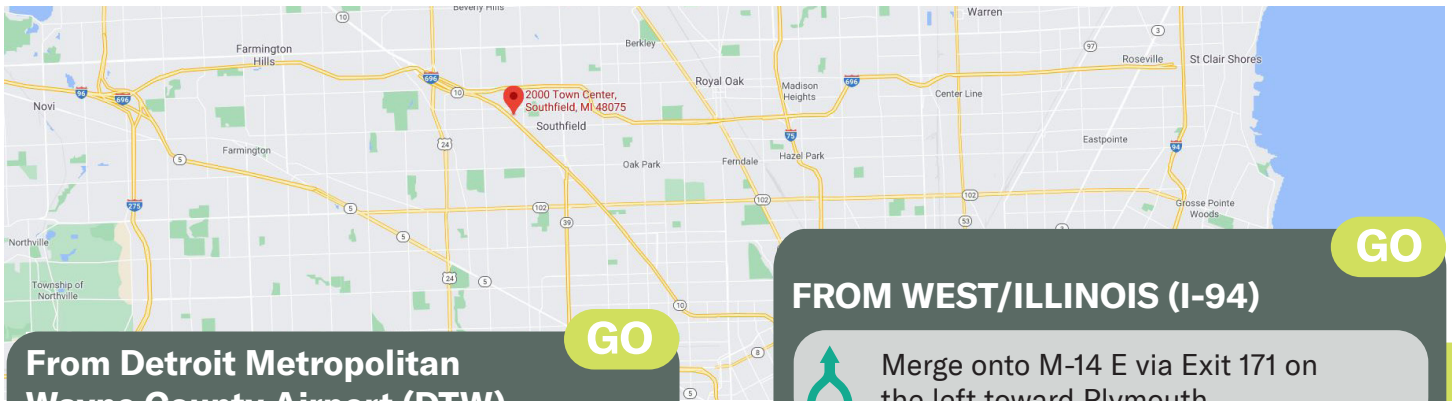

Merge onto I-94 E toward Detroit



Take the Exit 204 for MI-39 N/
Southfield Fwy



Merge onto M-39 N/Southfield Fwy



Take the MI-10 N exit, EXIT 16, on
the left toward Lansing/I-696 W



Merge onto M-10 N



Take Exit 15 toward Evergreen Rd/10
Mile Rd



Merge onto Northwestern Hwy



Turn right onto Town Ctr



Follow signs to 2000 Town Center



Enter the 2000 Town Center lobby

Take the elevator to the 13th floor

GO

FROM WEST/ILLINOIS (I-94)



Merge onto M-14 E via Exit 171 on
the left toward Plymouth



Merge onto I-275 N



Merge onto I-696 E via Exit 165 towards
Port Huron



Take Exit 11 toward Evergreen Rd



Merge onto W Eleven Mile Rd



Turn right onto Central Park Blvd



Turn right onto Civic Center Dr



Turn right onto Town Ctr

Enter the 2000 Town Center lobby



Take the elevator to the 13th floor

Parking

More than 90 surface parking spaces are located directly in front of the 2000 Town Center lobby for the convenience of clients and guests. Enclosed pedestrian bridges offer convenient, protected access to a four-level parking structure.

FROM SOUTH/OHIO (I-75 N)



Take the MI-39/Southfield Rd, Exit 41



Keep left to take the ramp toward the Henry Ford



Turn left onto MI-39 N/Southfield Fwy



Merge onto M-39 N/Southfield Fwy



Take the MI-10 N exit, EXIT 16, on the left toward Lansing/I-696 W



Merge onto M-10 N



Take Exit 15 toward Evergreen Rd/10 Mile Rd



Merge onto Northwestern Hwy



Turn right onto Town Ctr



Follow signs to 2000 Town Center



Enter the 2000 Town Center lobby

Take the elevator to the 13th floor

FROM NORTH/FLINT (I-75 S)



Merge onto I-475 S toward Detroit



Merge onto I-75 S



Take Exit 75 towards Square Lake Rd (I75BL)



Merge onto E Square Lake Rd



Turn left onto Lahser Rd



Turn left onto Northwestern Hwy



Turn left onto Civic Center Dr



Turn right onto Town Ctr

Enter the 2000 Town Center lobby



Take the elevator to the 13th floor

PUBLIC TRANSPORTATION BUS LINE 60

Take Bus Line 60 heading towards "Northwestern & 10 Mile"



Get off at "Northwestern & 10 Mile"



Head northwest on Northwestern Hwy toward St. James



Turn right onto Town Ctr

Enter the 2000 Town Center lobby

Take the elevator to the 13th floor

FROM DOWNTOWN DETROIT



Start going NW on Woodward Ave/
Woodward Ave-Automotive Heritage
Trail/M-1 toward E Montcalm St



Turn left onto E Fisher Fwy



Turn right onto Grand River Ave



Take a slight right onto
John C Lodge Fwy



Take a slight left to take the
MI-10 N ramp



Merge onto M-10 N



Take Exit 15 toward Evergreen Rd/10
Mile Rd



Merge onto Northwestern Hwy



Turn right onto Town Ctr



Follow signs to 2000 Town Center



Enter the 2000 Town Center lobby

Take the elevator to the 13th floor

PUBLIC TRANSPORTATION BUS LINE 400/405



Take Bus Line 405 heading towards
"Northwestern Hwy to Ford Medical Ctr"
or Line 400 heading towards
"Civic Ctr DR-11 Mile to OCC"

Get off at "Evergreen + Goldwin"



Head west toward St James



Turn left onto St James



Turn right toward Central Park Blvd/
Town Center



Turn left onto Central Park Blvd/Town
Center



Turn right onto Town Ctr



Turn left to stay on Town Ctr



Follow signs to 2000 Town Center
